- 1. Send an 8(a) Offer letter to San Antonio, Texas SBA Office
- 2. Wait to receive the SBA's Letter of Approval (approx. 3–5 days) Send
- 3. Request for Proposal (RFP) to HCP Federal, LLC
- 4. HCP Federal, LLC submits Proposal
- Award the Sole Source contract to HCP Federal, LLC. The eligibility of a Participant for a sole source or competitive 8(a) requirement may not be challenged by another Participant or any other party, either to SBA or any administrative forum as part of a bid or other contract protest. 13 CFR § 124.517(a)
